Graduation parties with Alcohol could get parents/adults in trouble!

Graduations are around the corner and it is a time to celebrate as graduates leave one part of their lives and enter another. Parents may feel pressured to offer alcohol at teen parties or think under their roof nothing bad will happen.

Youth alcohol consumption is significantly contributed to high risk sexual activity, assaults and accidental deaths at teen parties. Underage drinking is especially dangerous when those young people drive home after drinking at a graduation party.

Do you know what the Consequences are for Social Hosting?

Criminal Liability
Up to six months in County Jail
\$1,000 Fine

Civil Liability Up to \$1,500 Fine

Recovery of police response cost included. Salaries and benefits of Law Enforcement and/or Emergency Response Services. The cost of medical treatment to or for any emergency service personnel injured while at the scene of the gathering. The cost incurred for damages to emergency services equipment.

What is Social Hosting?

An adult who hosts a social gathering and provides or allows minors under 21 to consume alcoholic beverages in a private or public property.

SOCIAL HOST ORDINANCE

- Holds adults/parents and property owners accountable in hosting a party that provides alcohol to underage teens.
- This is a new civil violation that allows law enforcement to cite the parent/adult with a citation right on the spot.
- Social hosting of an underage drinking party poses an immediate threat to the public health, safety, and community welfare.
- Holding underage drinking parties IS A CRIME.

Consequences:

- Assaults
- Burglaries
- DUI's
- Teen Pregnancy
- Death

Responsabilidad Penal
 Hasta seis meses en la cárcel del condado y multa **\$1,000**

Responsabilidad Civil Multa arriba de **\$1,500**

El consumo de alcohol en menores de 21 años dentro de una propiedad privada o publica, ES MUY COSTOSO. Los costos incluyen servicios de emergencia, tales como:

- Salario, beneficios, y tratamiento medico a la persona lastimado/a durante la fiesta o reunion. Tambien incluye daños al equipo de servicios de emergencia.

¿Que es un Anfitrión Social?

Un adulto que organiza una reunion social y provee o permite que menores de 21 años de edad consuman bebidas alcoholicas en una propiedad privada o publica.

ORDENANZA de ANFITRION SOCIAL

- Mantiene adultos/padres y dueños de propiedades responsables por organizar fiestas que proporcione alcohol a jóvenes menores de edad.
- Esta es una nueva violacion civil que permite a oficiales de la autoridad multar a los padres/adultos en el momento.
- Una fiesta social donde hay menores de edad tomando puede traer amenazas inmediatas ala salud, seguridad, y bienestar social.
- Ser un Anfitrión Social de fiestas y reuniones es UN CRIMEN.



Consecuencias:

- Asaltos
- Robos
- DUI
- Embarazo de adolescente
- La muerte
