



Keys to Success Campaign *Helping Families Open the Door to Recovery*

Born out of the desire to provide families with resources and services beyond the recovery program, Sun Street Centers started the *Keys to Success* campaign in 2014 to better equip families for success in long-term recovery. The key symbolizes their first home in recovery. Since its inception and through the generous support from our donors, the *Keys to Success* campaign has helped with the provision of additional parenting classes, Ala-Teen, as well as additional counseling services and job development.

Safe Teens Empowerment Project in Seaside, Salinas and South County

One of the STEPS' biggest projects this year has been presenting the In One Instant Program. This program makes distracted, reckless, and impaired driving personal and relevant. 



Dear Alcohol...

There is no return address on this letter, because I don't want you to find me again. Many people fear you, many detest you. But I do not. Not even now. You are, if you will forgive me, generally speaking just a liquid; you hardly had the capacity for any malicious forethought, regarding our tempestuous relationship.

You are a social pleasure for the majority of people and those who know your powers hold relationships with you responsibly - **my pain, as great as it was, clearly was enough to explain our introduction, but certainly not enough to justify it.** It was always your arms in which I'd end up. I remember, once, I encountered you as an experiment - no justice at all was done to your power, but I saw someone else's face turn pale at your kiss, and an hour later, he died driving through the thin veil between here and forever.

As I remember my first kiss, I remember the first time I let you and you alone inside me - never before had crawling on my belly to a toilet and throwing up all contents of my insides felt so incredibly euphoric. People might accuse my relationship with you as 'hedonistic', but there is little hedonism in the amount of damage and pain I put myself through on our relationship's account. By the end, not even the highs, not even by the time I trusted you enough to let you enter every single cell of my body, could hinder my almost-too-late realization that you couldn't make me happy, and that you never really had.

I was losing everything to you, Alcohol. **I gave you my prospects, my education, my pride, my dignity, almost all aspects of my human relationships,** my friends who were too disgusted or embarrassed by my addiction to continue to see me, my friends who killed themselves over you, my inability to leave the house for anything other than you, not to mention thousands of dollars dwindled away.

I had fully realized that my life as a drunkard could not continue, logistically, financially, emotionally, spiritually or physically. Unfortunately, **you had taken away even the basic survival instincts and all I could think to do was to kill myself, by overdose of you** - and a few friends of yours, Valium, and Norco. Thankfully, my 'Higher Power' in the form of other Recovered people decided otherwise.

I still struggle to believe I really shall be free of you forever, but if I find myself on my deathbed, without you next to me, I'll die free from an old toxic love of whom I no longer need be afraid. **Because, by then...I'll have conquered you,** and all the obstacles you laid out before me. I'll have reclaimed all things you took from me that mattered, and I'll have led a life worth looking back on.
