Opioid epidemic, marijuana legalization, drunk driving - these are issues that can effect every man woman and child on the central coast. This year we were proud to celebrate our 50 year anniversary of combating the disease of alcoholism and addiction. We are equally proud to double down on our efforts to improve the health of families in Monterey and San Benito counties. We opened 5 new programs last year! Women's perinatal residential recovery in Hollister, Teen outpatient counseling in Seaside, Sober Living housing for women in recovery in Salinas, a Sobering Center for people intoxicated in public, also located in Salinas, and outpatient in Soledad for men and women. This year we have already incorporated the mental health and medical model into our Social Model of recovery through Medi-Cal services. This gives the ability to provide clinical counselors and social workers and care for those individuals with mild to moderate mental illnesses and addiction. And we are in the process of opening a full service recovery center in King City! We have had a lot of success through community partnerships as you will see in these pages. Your ongoing commitment to support what we are doing is the reason we have been able to grow. You are one of the partners along this journey with us. You make the difference in your community. ## expanding in king city

Thanks to grants from the State of California Board of Community Corrections, City of King, Monterey County, and Central California Alliance for Health - Sun Street Centers has purchased and is renovating a half-block property in the downtown area of King City. This new facility will house both men's and women's residential, and outpatient and eventually youth services and a sober living environment. We are grateful to those who helped us move into this wonderful town and to the residents who have embraced us.

### the Anne C. Leach Scholarship Fund

**Since the fund's inception, Sun Street Centers has been able to award** \$45,500 in scholarships to **alumni of our Men's Residential Program. And we have set aside another** \$72,500 in a stewardship fund at the Community Foundation for Monterey County for the future.









On the campus at **Men's Residential** in Salinas, there is a patio filled with bricks. These bricks symbolize hope for the future, thanks to the Anne C. Leach Scholarship. **The Anne C. Leach Men's** Residential Scholarship Fund was created for men who do not have the financial means to enter and attend the program, but have the sincere desire to recover, heal and thrive. The money raised through the fund is used to cover a portion of the program fees of residents who have successfully finished the program, are giving back through volunteerism, and are working to pay off their fees. It is a merit-based scholarship.

Sun Street Centers expanded our focus on serving women in 2018, and thanks to our community supporters, we were able to open a new **Women's Residential Treatment** program in Hollister, CA, serving women and their small children using a social-model curriculum that views the participant as a student, not a patient. In addition to this innovative approach, we continue to stand by our mission to support women through our Sober Living Environments, including ones in Salinas, Hollister, and our family recovery community at Pueblo del Mar in Marina.

# youth

In 2018, Sun Street Centers' Safe Teens Empowerment Project (STEPS) has officially been combating teen substance abuse for more than 20 years. During our last fiscal year STEPS empowered 77 young adults to mentor more than 6,044 students and 3,056 community members in more than a dozen schools and public forums countywide to avoid drinking, prescription drug abuse, and tobacco and vaping use. Many STEPS participants, both leaders and class participants, are from low-income or working-class families. In addition to this upstream approach, Sun Street Centers is working to provide intervention programs for youth who have been convicted of a first offence, this is the pre-diversion program, we call The Road to Success.

The Road to Success, open to teens ages 13 to 17, is for first time offenders convicted of minor, non-violent misdemeanor crimes in Gonzales, Soledad, Greenfield and King City. The collaborative goal is to ensure that these youth have the opportunity to participate in a strength-based and pro-social program that could prevent school expulsion and guide youth away from future illicit activity.

We would like to thank these four cities for standing behind our youth, to ensure their future remains bright and free from addiction by sharing the cost of this program after the state grant ended.

We have seen the great need for help for kids who don't have the support and guidance they need. We hope the cities in the area continue to see the benefit of your program.

Although much has been written, studied, and developed concerning the treatment of those struggling with addiction, not much has been developed in the way of fostering family healing within the addict's close relations. Many fail to recognize the effect the addict's use and behavior have had on the family. Family members themselves don't always recognize the full impact of addiction in their lives. For many, returning home may not be as joyous as one would hope. Therefore, Sun Street Centers is furthering our commitment to families through the programs at Pueblo Del Mar in Marina, family empowerment nights in Salinas and an annual Family Fun Day BBQ where families can gather and celebrate their recovery with one another.

Over 60% of the children in CPS\* have been **reunited** with their parents this past year.


